REQUEST FOR CANCELLATION OF THE RECORDING OF A LICENSE
(Rule 20*bis* of the Common Regulations)

IMPORTANT – POMEMBNO:

- (i) This request may be presented by the holder or by the Office of the Contracting Party of the holder or the Office of a Contracting Party with respect to which the license is granted. It must be signed by the holder (or his representative recorded in the International Register) or by the Office through which it is presented. – *To zahtevo lahko predloži imetnik registracije, urad pogodbenice imetnika ali urad pogodbenice, za katero se daje licenca. Podpisati jo mora imetnik registracije (ali njegov zastopnik, vpisan v Mednarodnem registru) ali pa urad, prek katerega je zahteva predložena.*
- (ii) One single form may be used to request the cancellation of the recording of the same license in respect of several international registrations of the same holder – ***zahteva za izbris vpisa licence se lahko predloži na enem samem obrazcu za več mednarodnih registracij istega imetnika.***
- (iii) A request for the cancellation of a license is exempt from the payment of a fee. – *Zahteva za izbris licence je oproščena plačila pristojbine.*
- (iv) **Where there are several licenses recorded in respect of the international registration(s), it should be clearly indicated which license the cancellation concerns. – Če je za mednarodno registracijo oziroma za registracije vpisanih več licence, je treba jasno navesti, na katero licenco se izbris nanaša.**
